Eligibility

Eligible Institutions	<p>ANR may fund research organisations and undertakings, as defined by the EC regulation on State aid for research, development and innovation (see the ANR Funding regulations for further reference).</p> <p>Only research organisations that have their primary establishment in France may be funded.</p> <p>Within this framework, public research institutions such as EPST, EPIC, Universities, University hospitals as well as foundations can apply, in general for up to 100% of so called “marginal” costs. This list is not comprehensive and funding rates vary.</p> <p>Enterprises may also be eligible: Funding rates vary based on types of research and types of enterprises. For fundamental research, maximum rates of funding are: 45% of total costs for SMEs, 30% for larger companies.</p> <p>Please refer to https://anr.fr/fr/rf/ for full details.</p> <p>Countries subject to sanctions applicable to the research field by the European Union authorities are excluded from this call. Projects involving Partners established in these countries will be declared ineligible by the ANR. At the date of publication, these exclusions concern partners from the following countries Russia, Belarus. This list may evolve in case of new sanctions decided by the European Union.</p>
Additional requirements	<p>The ANR funded Partners must communicate to ANR the Scientific reports, Consortium Agreement & Data management plan required by JPND.</p> <p>Financial reports must be communicated to ANR according to the provisions of the ANR Funding regulations.</p>

	If applicable, Declarations of Due Diligence for the financed projects (Nagoya Protocol) must also be transmitted to ANR in due time.

Budget restrictions	<p>The ANR has a maximum funding per Partner for this call: each Partner can request maximum 260 000 €.</p> <p>The maximum amount is increased to 310 000 € for a French partner in charge of the consortium coordination.</p> <p>Minimum amount per Partner: 15 000 €</p>
Eligible costs	<p>Eligible costs and rates of funding depend on the type of Partners. Among others, eligible costs may include the following:</p> <ul style="list-style-type: none"> • Personnel costs; • Equipment costs; • Consumables and animal costs; • Travel and subsistence costs; • Subcontracting costs. • Overheads (13.5% of total costs for Partners funded at “marginal” costs). <p>Subcontracting costs cannot exceed 50% of the total costs of a Partner.</p> <p>Please refer to ANR's Funding regulations (https://anr.fr/fr/rf/) for full details.</p> <p>Costs of clinical trials are not eligible for ANR.</p>
